## Frequently Asked Questions

#### **PARKING**

HOA Rules and Regulations prohibit parking anywhere on the grass or obstructing any sidewalk within the community. Overnight parking on the street is prohibited and parking on the street during daylight hours is allowed only as a last resort and subject to other restrictions. Therefore, the owner must make provision for parking of any vehicles used by occupants and visitors.

Heavy vehicles, commercially marked vehicles, boats, RVs, and trailers are not permitted to be parked overnight on any driveway or anywhere on the street in the community. Other restrictions apply. Consult the Rainberry Villas HOA Rules and Regulations for more information.

#### **GATE ENTRY RFID TAGS**

The Rainberry Lake Entry Gate is operated by a Radio-Frequency-Identification system that consists of a small sticker that is generally placed on the owner's vehicle windshield. New owners must purchase RFID Tags from the HOA at the cost of \$20 each (cash only), and the Tags must be applied to the owner's vehicle(s) by an HOA representative and any attempt to remove or move the tag to another vehicle will result in disabling the tag. To request RFID Tags, the owner must send an email with their name, address and phone number to RFID@rainberryvillas.com.

There is also a system called OpenPath that enables a resident to open the Entry Gate using their cellphone however this system is only to be used when the resident is traveling in a vehicle other than their own, e.g., rental, taxi, loaner or friend's vehicle. <a href="mailto:OpenPath@rainberryvillas.com">OpenPath@rainberryvillas.com</a>

Note that residents that have their cell phone number(s) programmed in the callbox may call themselves to open the gate. Callbox@rainberryvillas.com

Persons forcing the Entry Gates or Tailgating another vehicle will be fined or arrested.

## **HOA MONTHLY PAYMENT**

Rainberry Villas property owners are required to pay a monthly HOA fee. New owners should contact the Rainberry Villas HOA Accounting Office to request a Payment Coupon Book or arrange for automatic payment of their monthly fee.

#### **AFTER HOURS VISITORS & DELIVERIES**

The Guard House is open 365 days a year, from 8am to 8pm. Visitors and Deliveries must check in with the guard and be called through. Visitors arriving outside of these hours must use the Call Box. Instructions for operating the Call Box may be downloaded / printed from the website <a href="https://www.rainberryvillas.com">www.rainberryvillas.com</a> under Rainberry Villas HOA Documents and Forms.

#### SWIMMING POOLS, TENNIS COURTS, BASKETBALL COURT

The south (main) Swimming Pool and Spa are open every day from 8am to dusk (unless otherwise posted). The tennis courts and basketball court are open 8am to dusk. These facilities are accessible with a key. The new owner should have obtain a key from the seller. If not, please consult the website <a href="https://www.rainberryvillas.com">www.rainberryvillas.com</a> under 'Living in the Villas'.

Also, please read and follow the rules posted at these facilities.

### **LAKE DOCKS**

Docks are for the exclusive use of the property owner's to which they are assigned. Please stay off the docks. Please consult the website for more information on docks, boating in Rainberry Lake, public boat-ramps, and storage (parking) of trailers and boats.

## <u>TRASH</u>

Household Trash and Recycle are picked up on Tuesdays. Household Trash and Bulk Trash are picked up on Fridays. Residents must not put anything at the curb before the afternoon on the day before a scheduled pickup, and must return the empty receptacles to a non-visible location (in garage or behind a wall or fence) by the end of the day of pickup. Trash left out on the wrong day will result in a fine from the City of Delray. ## Frequently Asked Questions Answered (continued)

#### **IRRIGATION SYSTEM**

The Villas of Rainberry HOA owns the irrigation system throughout the community, both surrounding and within your property boundaries. Only the HOA's Irrigation Contractor is authorized to perform modifications or maintenance to the system. Therefore, before performing any landscape or construction work that involves digging on the property, you must contact the HOA Director of Landscaping. This includes new plantings, fences, patios, walks, driveways or buried electrical and plumbing.

Our goal is to ensure an orderly workflow within the community.

Failure to coordinate with the HOA Director of Landscaping may necessitate removing the unauthorized features, disconnection from the community irrigation system or charges for corrective maintenance to the irrigation system.
